Meeting Minutes February 28, 2023

Call to Order/Welcome: Pamme Eades called the meeting to order at 5:45 PM.

## **Approval of Minutes:**

The January 2023 meeting minutes were modified regarding a per diem policy. A motion had been made, was seconded and unanimously approved to follow the city's per-diem policy with the foundation president having discretion to pay the per diem in advance. This measure had been mistakenly omitted from the minutes. Rebecca Lorick made a motion to approve the January 2023 minutes, with the modification(s) stated, and Barbra Corbitt second the motion. The minutes were unanimously approved.

Pamme Eades introduced new board member Trinessa Dubas who is a business owner in the City of Cayce.

- Pamme recommended for balances in the restricted funds be moved to cover the cost for the Lexington Health Grant AED (\$90.87 from the tent and sledgehammer fund and \$692.44 from the speed trailer).

#### **New Business:**

#### Seed money:

Pamme requested for 10% of non-dedicated fundraisers be moved into emergency fund to create \$5,000.00 seed money fund for fundraising. Karen Sanders made a motion to create this fund and Russ seconded. The motion was unanimously approved.

- Golf tournament. Miles Fisher has a scheduled zoom meeting with a potential promoter.

#### **Police Department Updates:**

- o Chief Cowan announced a \$15,000.00 donation was made to the foundation by the SCLEOA.
- o Heroes Hike in Greenville, SC. Chief Cowan reported one of the miles in the event is in honor of Drew Barr. Currently Cayce PD has 12 participants in the 6-mile loop and 6 in the 12-mile loop. Separate donations of \$1,000.00 and \$1,500.00 have been made specifically for Cayce PD participants. Chief Cowan requested funding for one night lodging for the 12-mile participants (3 rooms). Furthermore, Chief Cowan requested funds for 12 Drew Barr T-shirts for the participants. Russ Shumard made the motion to approve this funding and Dori Benitez second. The measure was unanimously approved.
- Chief Cowan requested funding for K-9 certification for 4 officers. This training is from March 5-10 in Mt.
   Pleasant. He requested \$4,493.44 to send the officers to the training. This cost is for lodging, food, and for the certification training. Russ Shumard made the motion and Miles second. The measure was unanimously approved.
- o Chief Cowan requested funding for vehicle insert for therapy K-9 Hudson. The total cost for the equipment is \$2,661.40. Being that Hudson is assigned to and serves in the SRO unit with Officer Fournier Lexington County School District #2 would be responsible for 75% of this cost. Chief Cowan recommended the foundation pay the total amount up front and then invoice the school district for 75% of the cost. Karen sanders made the motion to approve this funding and Dori Benitez second. The measure was unanimously approved.
