**CLASS TITLE: OPERATOR TRAINEE
ENVIRONMENTAL SYSTEMS**

GENERAL DESCRIPTION OF CLASS

The purpose of the class is to learn water/wastewater treatment techniques. The class is responsible for testing potable water/wastewater and monitoring the treatment equipment in the water/wastewater plant. The class works according to set procedures under direct supervision.

ESSENTIAL TASKS

The tasks listed below are those that represent the majority of the time spent working in this class. Management may assign additional tasks related to the type of work of the class as necessary.

Operates trailer to load empty sludge beds; cleans trailer and truck.

Cleans sludge beds, raw water intake screens, lab, kitchen and bay areas.

Enters water/wastewater treatment data into computer.

Performs preventative and corrective repairs and maintenance on plant equipment, i.e. repairs broken chemical feed lines as needed; maintains and repairs fork lifts and lawn mowers, etc. as needed.

Operates, maintains and utilizes various types of equipment, machinery and tools in the performance of duties such as trucks, fork lift, meters, calculator, mechanic's tools, plumber's tools, etc.

Interacts and communicates with various groups and individuals in the performance of duties such as customers, supervisors, City staff, sales representatives, etc.

Performs housekeeping and groundskeeping duties at the wastewater plant and pump stations, water plant, water tanks and surrounding areas.

Studies correspondence course materials in preparation of taking the examination for the "D" permit in water/wastewater treatment.

Performs general preventative maintenance on equipment/trucks such as checking fluid levels, tire pressure, etc.; ensures trucks and equipment are kept clean and in proper operating condition.

Operates and maintains the belt press within the plant for the purpose of monitoring sludge to ensure same is acceptable by landfill; performs minor repairs to screw press and other plant equipment as needed.

Responsible for monitoring lift stations, and performing various plant operations including but not limited to loading sludge onto trucks, hauling sludge to landfill, hauling sand to job sites, repairing aerators, performing manual labor, etc.

CLASS TITLE: OPERATOR TRAINEE

INVOLVEMENT WITH DATA, PEOPLE AND THINGS

DATA INVOLVEMENT:

Requires comparing or inspecting items against a standard.

PEOPLE INVOLVEMENT:

Requires following instructions and orders of supervisor.

INVOLVEMENT WITH THINGS:

Requires handling or using machines, tools, or equipment requiring moderate instruction and experience such as water/wastewater treatment equipment, tractors and computers.

COGNITIVE REQUIREMENTS

REASONING REQUIREMENTS:

Requires performing routine work using common sense.

MATHEMATICAL REQUIREMENTS:

Requires performing addition and subtraction, multiplication and division and/or calculating ratios, rates and percents.

LANGUAGE REQUIREMENTS:

Requires reading simple sentences, instructions, or work orders; writing simple sentences and completing simple job forms; speaking simple sentences using basic grammar.

MENTAL REQUIREMENTS:

Requires performing manual tasks prescribed by standard practices but which may require computation, the use of several procedures, and the use of independent judgments with obvious choices; requires normal attention for accurate results.

VOCATIONAL/EDUCATIONAL AND EXPERIENCE PREPARATION

VOCATIONAL/EDUCATIONAL PREPARATION:

Requires high school or GED or specialized vocational training.

SPECIAL CERTIFICATIONS AND LICENSES:

Must possess a valid South Carolina driver's license

EXPERIENCE REQUIREMENTS:

Requires 1-2 years of mechanical/technical experience, and 5-11 months experience as an equipment operator or any equivalent combination of training and experience which provides the required knowledge, skills and abilities.

AMERICANS WITH DISABILITIES ACT REQUIREMENTS

PHYSICAL AND DEXTERITY REQUIREMENTS:
